**Purpose.** The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families

**Applicability.** Form HUD-50075-HCV is to be completed annually by **HCV-Only PHAs**. PHAs that meet the definition of a Standard PHA, Troubled PHA, High Performer PHA, Small PHA, or Qualified PHA do not need to submit this form. Where applicable, separate Annual PHA Plan forms are available for each of these types of PHAs.

**Definitions.**

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers, and was designated as a high performer on both of the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments if administering both programs, or PHAS if only administering public housing.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, or at risk of being designated as troubled, that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceeds 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment, and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceeds 550, and that was designated as a standard performer in the most recent PHAS and SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined, and is not PHAS or SEMAP troubled.

Provide the projected number of project-based units and general locations, and describe how project-basing would be consistent with the PHA Plan. <b>In response to HOTMA changes to the Project Based Voucher Program (PBV) and subsequent HUD implementation guidance, BHA determined that its Section 8 program participants would benefit from the availability of new project-based voucher units in affordable housing development by non-profit organizations committed to perpetual affordability and would affirmatively further Fair Housing. This action is consistent with the 5 -Year PHA Plan, which identifies the need for new affordable housing units available to Section 8 HCV participants. In FY2018, with HUD approval, BHA began accepting applications for Project-Based Vouchers. As of January 2019, 25 PBV vouchers in a new housing development in South Burlington have been issued. BHA has executed an AHAP for another development in South Burlington and continues to accept applications for additional project-based vouchers. The final number and location of new PBV units in FY2019 will, subject to the HUD cap, depend on the number and quality of applications received, Section 8 HCV funding and voucher availability.</b></p>
